

Student Right-to-Know Information 2017

The Student Right-To-Know Act requires all institutions eligible for Title IV funding to disclose graduation rates of degree seeking students to all students and prospective students. The population against which on-time graduation rates are calculated are based on full-time, undergraduate students who began their studies in Fall 2010 and would have been expected to graduate within 150% of the published program length.

Federal Subsidized Stafford Loan recipients who did not receive Federal Pell:

Cohort.....	136
Completed in 150% timeframe	61
Percentage.....	45%

Recipients of neither Federal Subsidized Loan nor Federal Pell:

Cohort.....	239
Completed in 150% timeframe	119
Percentage.....	50%
